

**Memorandum of Understanding
Between
Faculty of History and Philosophy of Borys Grinchenko
Kyiv University & Council on Pacific Affairs**

On the principle of willingness and mutual benefits, enhance exchanges and cooperation, this MOU is entered by and between:

- Faculty of History and Philosophy of Borys Grinchenko Kyiv University and,
- Council on Pacific Affairs (hereinafter referred to as "CPA").

Article I. Principles and Objectives

- 1.1. While carrying forward the spirit of better mutual understanding, Faculty of History and Philosophy of Borys Grinchenko Kyiv University and the Council on Pacific Affairs shall work on initiative interpretation, policy analysis and thematic researches.
- 1.2. Cooperation between Faculty of History and Philosophy of Borys Grinchenko Kyiv University and CPA is dedicated to serving government policymaking and facilitating people-to-people exchanges, as well as contributing to regional development and prosperity.

Article II. Means of Cooperation

- 2.1. Faculty of History and Philosophy of Borys Grinchenko Kyiv University and CPA will offer a platform for exchanges and cooperation to facilitate mutual researches and where information, resources and achievements are shared.
- 2.2. Faculty of History and Philosophy of Borys Grinchenko Kyiv University and CPA may republish articles with the original link, and link webpages to encourage positive participation & contribution.

Article III. Organizational Arrangements

- 3.1. Both Secretariat of Faculty of History and Philosophy of Borys Grinchenko Kyiv University and CPA shall collaborate closely to ensure quality and direction of relevant activities within the framework of this MOU.
- 3.2. Both Secretariat of Faculty of History and Philosophy of Borys Grinchenko Kyiv University and CPA shall appoint contact persons to be in charge of day-to-day academic exchanges and cooperation.

Article IV. Modification and Termination

- 4.1. Both Faculty of History and Philosophy of Borys Grinchenko Kyiv University and CPA may propose modifications of the provisions in this MOU.
- 4.2. This MOU shall terminate upon mutual consent by Faculty of History and Philosophy of Borys Grinchenko Kyiv University and CPA or upon either's party failure to fulfill it. The party that proposes the termination of this MOU shall inform the other party in written forms.

Article V. Other Matters

- 5.1. In case of differences in interpreting certain clauses in this MOU, either Faculty of History and Philosophy of Borys Grinchenko Kyiv University or CPA may issue a written notice to the other for consultation. Faculty of History and Philosophy of Borys Grinchenko Kyiv University and CPA may revise the MOU upon agreement.
- 5.2. This MOU shall enter into force upon signature by both parties and remain in effect for duration of five years.
